The application shall be accompanied by an executed bond in the sum of \$2,000. The bond shall be for the use and benefit of all persons that may enter the carnival and shall be conditioned on: (1) The delivery in good condition of goods, wares, merchandise, services, etc., by vendors or operators at the carnival; and (2) The indemnification of purchasers and customers from any and all defects in material and workmanship that may exist at the time of delivery of the goods, wares, merchandise or services and discovered by the purchaser or customer within 30 days after delivery. **The application shall be accompanied by a copy of a certificate of insurance covering the carnival for the duration of the permit, with the following types and limits of insurance:** (1) Comprehensive general liability insurance with minimum limits of \$1,000,000 as the combined single limit for each occurrence of bodily injury, personal injury, and property damage; (2) Automobile liability insurance covering all owned, hired, and non-owned vehicles in use by the carnival, its employees and agents, with minimum limits of \$1,000,000 as the combined single limit for each occurrence for bodily injury and property damage; (3) The coverage amounts set forth above may be met by a combination of underlying and umbrella policies so long as in combination the limits equal or exceed those stated. Sec. 62-107. Conditions of operation: (a) No carnival shall be open for business from 10 p.m. to 12 noon; (b) There shall be present at all times at the carnival a supervisor at least 21 years of age; (c) No person operating a carnival shall allow the operation of any sound equipment at any place or in any manner that will disturb the peace and quiet of persons residing in any residential building or operating in any business building located within 400 feet of the premises on which such carnival is located. Sec. 62-111. Violation - It shall be a violation of this article to operate a carnival that does not comply with all terms and conditions of this chapter and any other ordinances or laws of the city or state. (Ord. No. O-2000-002-01)
